2022 AWSC Spring Convention will be held March 25-27, 2022 at the Radisson Hotel & Convention Center in Green Bay. Wisconsin snowmobile clubs from across the state will gather for this annual meeting to elect officers, discuss the snowmobile industry, trail maintenance, safety & legislative activity. It's a good time to also meet your AWSC officers, directors, & county representatives. At the January meeting, Yellow Thunder unanimously voted Mike & Alex Ballweg and Gary & Ruth Tupper to attend as delegates on behalf of Yellow Thunder. Safety Alert – Once the trails are open, please be careful if you are riding on Lake Wisconsin. It can be challenging for a number of reasons. There could be areas of thin ice due to the river's current. The lake also is known for ice heaves, which can create dangerous ice shifting that can stop a snowmobile in its tracks. Finally, there may be areas where the snow on the lake has been plowed by businesses or ice fisherman, leaving snow banks that can create a hazard for snowmobilers, so please be careful!

Groomer Fuel – We'd like to thank Midway Oil in Sauk City and Corey Oil of Beaver Dam for donating the fuel for our groomers again this year. Please support these local businesses who are vested in our communities and for their generosity to Yellow Thunder!

Trails: We've said it twice now and we'll say it again for a third time, as we get closer to opening the trials...due to some snowmobilers who failed to stay on the marked trail last year and chose to cut across the field to get to trail #19 from Okee to County Road J, that trail is now closed. It is so important for riders to understand that 95% of our trail system is farmland. Going off trail can result in crop damage and affects our farmers' livelihood. If you need trail access, please contact the landowner. If you don't know who the landowner is, contact the club; we're here to help. Failure to contact the landowner increases the risk to lose more trails, and this impacts everyone who rides. Remember, riding is a privilege; not a right.
