There are two changes that the Board would like the membership to consider: 1) allow our monthly newsletters to be sent by either U.S. Postal service <u>or</u> by email; and 2) no longer require that elected Board Members take a year off after serving their 3-year term. The purpose of the 2nd change is to allow Officers of Yellow Thunder, whose positions are difficult to fill, the opportunity to stay on the Board and continue performing their officer duties to Yellow Thunder. These changes will be discussed at our March meeting, and then voted on at the April meeting (in accordance with our current by-laws).
